Resolution ResAP(2007)3 "Achieving full participation through Universal Design"
Report by the Committee of Experts on Universal Design (Accessibility) (P-RR-UD)

Council of Europe Resolutions and Recommendation are adopted by the Committee of Ministers (the decision-making body, which comprises the Foreign Affairs Ministers or their permanent diplomatic representatives)





Resolution ResAP(2001)1 of the Committee of Ministers of the Council of Europe on the introduction of the principles of Universal Design into the curricula of all occupations working on the built environments ("The Tomar Resolution"):

- applies to the 18 members states, parties to the Partial Agreement in the Social and Public Health Field, including Spain;

 provides a definition of Universal Design in a Committee of Ministers' adopted text

(UD aims... to make the design and composition of different environments and products accessible and understandable to, as well as usable by, everyone...)

Recommendation Rec(2006) 5 of the Committee of Ministers (Council of Europe Disability Action Plan 2006-2015) is addressed to all the 47 member states of the Council of Europe

Council of Europe Disability Action Plan 2006-2015:

Universal Design is mentioned as "an effective way to improve the accessibility and the quality of the built environment, services and products".

Resolution ResAP(2007)3 "Achieving full participation through Universal Design"

 applies to the 18 members states, parties to the Partial Agreement in the Social and Public Health Field, including Spain;

 extends the definition and the recommendation to apply Universal Design principles to include: communication, information technology; and services

Resolution ResAP(2007)3 "Achieving full participation through Universal Design" (cont-d)

- the Committee of Minister recommends that the governments of the member states of the Partial Agreement..:

i. promote full participation in community life, and in particular, prevent the creation of new barriers by designing, from the outset, solutions that are accessible and usable for all; and in doing so, take into account and integrate as appropriate in their policy, legislation and practice the principles of Universal Design;

Resolution ResAP(2007)3 "Achieving full participation through Universal Design" (cont-d):

 - ii. be guided, in their processes of integrating Universal Design principles in policy, legislation and practice, by the measures advocated in the appendix to this resolution;

iii. promote the application of Universal Design in the implementation of Recommendation <u>Rec(2006)5</u> of the Committee of Ministers to member states on the Council of Europe Action Plan to promote the rights and full participation of people with disabilities in society: improving the quality of life of people with disabilities in Europe 2006-2015; 12

Resolution ResAP(2007)3 "Achieving full participation through Universal Design" (cont-d)

iv. assure to this end the widest possible dissemination of this resolution amongst all parties concerned, for example through awarenessraising campaigns and co-operation with the private sector and civil society, involving, in particular, non-governmental organisations of people with disabilities.






Promote full participation in community life


- prevent the creation of new barriers;

The 2007 Resolution on Universal Design (ResAP(2001)3)


- Ensure widest possible dissemination of awareness-raising campaigns



1st National Accessibility Plan 2004-2012, Spain






Description: The 1st National Accessibility Plan is a strategic framework to promote and consolidate the measures the Spanish Government, together with other government administrations and public and private organisations, plans to take to remove barriers and introduce the Design for All concept.





Universal Design principles integrated into the architectural education, Hungary

Description: Universal design principles are an integrated part of the undergraduate education of architects since 2002 in the Szent Istvan University, YMMF School of Architecture.

Universal Design features: The YMMF School of Architecture has introduced the Universal Design principles into the education via a compulsory course for all architects, following preparation of specific teaching materials and courses for educators. According to the resolution of the government 1015/2005 on "the barrier free environment and civil services for all", schools and universities involved in the education of all professions working on the built environment should introduce the principles of Universal Design in the curricula before 31 December 2005.
